Gasconade County Fair Livestock Exhibitor Behavior Rules

Any violations will be handled at the discretion of the Livestock Committee.

Livestock Exhibitors WILL ALWAYS:

- Keep alleyways and stalls clean -Maintain and care for their animals for the duration of the fair.
- Respect others' rights -Insure that animals are properly restrained (i.e. use neck ropes) -Obey all local, State, and Federal laws.
- Observe the GENERAL LIVESTOCK RULES in regard to vehicles on the grounds, and the stalling of animals in the barn from 9 AM through 9 PM

Market animal weigh-in from 8AM to 9:30AM on Thursday, July 25, 2019

Livestock Exhibitors WILL NEVER:

- Consume alcoholic beverages as a minor or illegal/un-prescribed drugs.** -Show an unruly/dangerous animal. -Use loud or offensive language.
- Disturb others while sleeping during curfew hours. -Behave in any manner that would tarnish your, or the Fair's reputation.
- Destroy or damage any property belonging to others, especially if it belongs to the Park or the Gasconade County Fair

By signing this form, you are agreeing to abide by the rules or accept dismissal from the Gasconade County Fair, forfeit all premiums, the rights to participate in the current year's show and sale, and possibly as well as not being permitted to participate in future Fairs.
