## Gasconade County Fair Livestock Exhibitor Behavior Rules

One purpose of the Gasconade County Fair is to provide Agricultural Producers, and especially Youth, the opportunity to showcase the results of their efforts. In addition, we hope to provide a pleasant and safe experience for visitors and guests at the Fair. With these purposes in mind, all Fair Exhibitors are expected to conduct themselves according to the rules set forth by the Fair Board and more directly the Livestock Committee. The following guidelines should be followed, as any violation will be handled at the discretion of the Livestock Committee.

- Livestock Exhibitors will:
- Keep alleyways and stalls clean
  - Maintain and care for their animals during the Fair
  - Respect the rights of others
  - Observe the rules in respect to those listed in the GENERAL LIVESTOCK RULES in regard to vehicles on the grounds, and the rules regarding the stalling of animals from 9:00 a.m. thru 9:00 p.m. in the barn
  - Obey all local, State and Federal laws
  - Insure that your animals are properly restrained while on the fairgrounds. (i.e. a neck rope should also be used)
  - Be available on Sunday morning to assist in loading your market animal

- Livestock Exhibitors will not:
- Be allowed to show an animal that is unruly/dangerous, or

- not in show condition
- Use loud or offensive language
  - Consume alcoholic beverages if under the legal age
  - Use illegal/un-prescribed drugs
  - Disturb others while sleeping during curfew hours
  - Behave in a manner which is a detriment to their, or the Fair's reputation
  - Destroy or damage property belonging to others, especially that of the Park system or the Gasconade County Fair.

Drugs, Underage Drinking, Fighting, Immoral Behavior will not be tolerated.

I acknowledge that I have read the above rules and agree to abide by them or will accept dismissal from the Gasconade County Fair and forfeiture of all premiums and the rights to participate in the Livestock Show and Sale. Moreover, I acknowledge that my actions may result in not being allowed to participate in future Fairs.
