## SPECIAL YOUTH MARKET SHOW LIVESTOCK RULES

An Exhibitor is not allowed to sell any item at the Gasconade County Fair, if they have or will sell an item at any other Missouri county fair or area fair (except for the Missouri State Fair or National Livestock Shows).

## I. All Youth Show Exhibitors must:

- a. Be an active member of a supervised youth organization (4-H or FFA). Be at least 8 years old and not more than 21 years old as of January 1st of current year. Must have a valid SMQA card, which must be shown when animals are weighed in at the fair.
- b. Must be a resident of Gasconade County or be a member of a 4-H Community Club or FFA Chapter within Gasconade County.
- c. Have a record on file with the organization that the exhibited animals are part of an approved organization project.
- d. Own and show the animal. If a situation arises the Livestock Committee will rule if the animal can be exhibited by another family member/exhibitor. Notification of situations must be presented in writing 30 days prior to show.
- e. Abide by the General Livestock Rules.
- II. Judging will be the Danish System where animals will be evaluated on its merit according to standards of the breed. Ribbon awards are blue, red, white, and no ribbon.
- III. Grand and Reserve Champion animals and hams must be offerd in the sale.
- IV. Exhibitors of market sale animals will:
- a. Continue to be responsible for animal's care after sale.
- b. All exhibitors must be present to sell their items.
- V. If an exhibitor shows 2 or more animals, they may sell only one animal. "Highest placing animal will sell at Auction." Exception if both exhibits receive a Grand or Reserve then both exhibits sell.

VI. If an exhibitor has a Champion item and chooses to sell another item, the proceeds from the Champion item will be donated to the Livestock Committee.

## **ENTRIES:**

- a. All entries will be submitted by going to http://gasconadecounty.fairentry.com/; by logging in through your 4HOnline family profile or creating a Fair Entry profile if FFA or breeder. Registrations for livestock classes will run from May 15 July 1. Please register early! Contact the Extension Office at 573-266-2701 if you need assistance. NO LATE REGISTRATIONS FOR LIVESTOCK WILL BE ACCEPTED.
- b. All entry fees, selling fees will be paid by credit/debit card online or check/M.O. mailed to the Gasconade County Fair Assn, P.O. Box 15, Owensville, MO 65066 by July 7, of the current year.
- c. Livestock Exhibitors must purchase their Season Passes at a participating local business.
- d. To be eligible to show and sell a market animal, the exhibitor must live in Gasconade County or be a member of a 4-H Community Club or FFA Chapter within Gasconade County.
