 2. Open Market Barrows & Gilt **These pigs cannot have been shown in any other class.**

3. Pee Wee - This class is for showing experience only. Open to all youth ages 6 through 9 (must show a hog entered in any other Swine Show class).

 Champion and Reserve Champion Female

8. Junior Spring Boar (farrowed 3-1 to 4-30, 2025)
 9. Senior Spring Boar (farrowed 2-1 to 2-28, 2025)
 Champion Boar and Reserve Champion Boar

Youth and District FFA will include 2 and 4 through 9 and be judged on the Danish system. Showmanship awards will be judged in these divisions: Junior, age 13 and under; and Senior, age 14 and over. Only those showing in the Open Swine show are eligible for this Showmanship drive.

- 3. Reservations will not be accepted until exhibitor registrations officially open online.
- 4. Campsites are reserved on a first come basis. Sites may be requested but are not guaranteed. Include request with payment.
- 5. Parking allowed within an individuals reserved site. Additional parking allowed if available. **Do Not Block** other campsites, driveway, dump-station, or dumpster.

RULES AND REGULATIONS FOR GASCONADE COUNTY 4-H AND FFA MARKET BARROW AND GILT SHOW AND SALE

Class number for 4-H & FFA Market Barrow and Gilt is Class # 1.

1. FINAL PLACING WILL BE DETERMINED BY JUDGE.
2. To be eligible to show and sell a barrow or gilt, exhibitor must be a member of a 4-H within Gasconade County or FFA within Gasconade County. All swine exhibited at the fair must have a Gasconade County Fair Tag and a EID Tag applied by the Livestock Chair. Each member may tag/weigh in 2 pigs and each family is allowed 1 alternate at tag in.
3. At the fair, both barrows and gilts will be allowed; a member will be allowed to show 2 barrows or gilts, however, sell only one, which must be the higher placing animal, unless the member has both grand and reserve champion. **Only 2 animals may be brought to the fair for Class #1**
4. The committee reserves the right to divide the barrows and gilts into classes according to weight.
5. Each pig must be registered under an exhibitor's name. No alternate pigs will be allowed.
6. Barrows and gilts will be weighed at the Fairgrounds as they come off the truck Wednesday between the hours of 8:00 a.m. and 5:00 p.m. This will be the selling weight. **Barrows and gilts must weigh at least 220 pounds to show.** Any animal not weighing 220 pounds will be allowed to show in the open show but will not sell. Any animal weighing over 300 pounds will be allowed to show and sell; **but at the sale, seller will only be allowed a maximum sale weight allotment of 300 pounds.**
7. The barrow and gilt show will be at 8:00 a.m. on Thursday. **Gilts will not be allowed to show in the breeding show.**
8. The sale will be on Saturday.
9. Sale order will be set by Swine Judge.
10. Entry fees will be \$4.00 per head.
11. Selling fee is \$25.00 per head.
12. The committee sets swine pens at a rate of one or two head per half pen, three or four per whole pen. **Absolutely no pen changes allowed without the Swine Committee Approval. No Exceptions. Absolutely NO ITEMS allowed in the alleyways or Tact Pen set-up before 5:00 p.m. or after all entries are weighed and penned.**
13. No water pans allowed - pigs must use a nipple-type waterer.
14. **All exhibitors must supply their own shavings for their pens.**
15. All market swine selling **must** have the official Gasconade County Fair tag in their ear.

16. All swine require an active CVI form for the duration of the fair and an EID tag as stated in the General Livestock Rules.
